AWISA was formed in 1986 by the principal suppliers to the Australian woodworking industry, to bring together suppliers of machinery, tooling, materials, fittings and services to the furniture, cabinet making, kitchen, joinery, shop and office fitting and other wood, timber and panel processing industries.

The main aims of AWISA are to promote and present industry exhibitions in Australia by organising one major exhibition every two years, and to encourage members to participate only in the Association's own exhibitions.

Other aims of the Association are to provide a means for the exchange of views among members of the industry; to further the interests of members both nationally and internationally; to represent members in negotiations at government level on matters of common interest to members; to represent members in negotiations for co-operation with other organisations affecting the woodworking industry, and/or to become members of such organisations; to obtain maximum publicity for the industry; and to maintain industry standards at a high level.
